

RL Quote 3PSP Agreement

THIS AGREEMENT entered into on the "Effective Date" set forth below between, Reverse Logistics Association (hereinafter referred to as "RLA") and the party identified as the company on the signature line below (hereinafter referred to as "Company").

In consideration of the mutual covenants and promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. In consideration of RLA fulfilling the duties and responsibilities set forth herein, for business awarded through the RL Quote process of RLA, the **Company agrees to pay a finder's fee to RLA according to the option the Company chooses. Check OPTION A or OPTION B below:**

OPTION A: Company shall pay to RLA a finder's fee of \$5,000 for business valued under \$1 million, \$10,000 for business valued at \$1-2 million dollars, and \$25,000 for business valued above \$2 million. Fee shall be paid within 60 days of Company being awarded a contract for services by the Customer.

OPTION B: A finder's fee of one percent (1%) of the net revenue received by the Company from the awarding of a contract for services by the Customer shall be paid to RLA on a monthly basis, for the duration of the contract. Net revenue shall be determined by the amount paid to the Company from amounts Invoiced to the Customer.

2. For purposes of this Agreement, the following definitions shall apply:

(a) The payment to RLA shall be made on all business related to the RFI that the Company has received after the "Effective Date".

(b) "Business" shall mean all services in the reverse logistics industry, including long-term exclusive contracts to purchase all returns from a Customer, resulting from a Request for Information (RFI) in RL Quote. Special situations will be considered and negotiated in good faith.

(c) "Customer" is the manufacturer or retailer who has engaged RLA to provide its RL Quote service as a means for finding potential service providers for the Customer.

3. RLA will sign a non-disclosure agreement, in addition to other documents which may be required by Customer and Company, to allow Company to disclose information related to the value of the business arrangements between Company and Customer for purposes of determining the finder's fee amount.

4. Either Party may cancel this agreement at any time by providing 30 days written notice to the business address of the other party. In the event of such a cancellation, Company will owe all fees due on sales as set forth in paragraph 1.

5. Company must be a Bronze Member (or above) of the Reverse Logistics Association.

6. RLA duties and responsibilities pursuant to this Agreement are as follows:

a) To allow Company to participate in the Request for Information (RFI) process.

b) Submit to Customers all Company responses to Requests for Information. Participation in the RFI process is non-exclusive to Company. Nothing contained herein shall prevent RLA from providing these same or similar services to other service providers. RLA is not an exclusive agent of the Company.

7. This contract encompasses the entire agreement of the parties and there are no other agreements of understanding, either written or oral.

8. This contract may not be modified or amended except in writing with the same degree of formality with which this contract has been executed.

9. Should any part or provision of this contract be adjudicated inoperative or invalid, the remaining provisions of the contract will remain in effect and operate as if the invalid or inoperative provision had never existed.

10. The interpretation of this contract and all transactions under it shall be governed by the laws of the State of California.
